Regulatory Statement: SCS Static Shielding Bags and Moisture Barrier Bags

EU Regulation (EC) No 1907/2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH)

SCS does not use conflict minerals (gold, tin, tantalum, or tungsten originating from the Democratic Republic of the Congo (DRC) or adjoining countries) in any formulated materials for above-listed products.

Substances identified by The Safe Drinking Water and Toxic Enforcement Act of 1986 are not intentionally added.

TSCA

None of the substances restricted by the U.S. EPA in the Toxic Substance Control Act of 1976 (TSCA), including the five Persistent, Bioaccumulative, and Toxic (PBT) chemicals identified and outlined in section 6(h) and which took effect Feb. 5, 2021, are used or intentionally added to these products.

Halogens

These products were not manufactured to contain or have intentionally added halogens. Desco Industries does not analyze for these halogens as they are not expected to be present.

PFAS and Model Toxics in Packaging Legislation

The regulated chemicals in the Model – lead, mercury, cadmium, and hexavalent chromium – are not intentionally added to any package or packaging component during the manufacturing process, and the sum of the concentration levels of incidentally introduced chemicals does not exceed 100 parts per million by weight. Furthermore, perfluoroalkyl and polyfluoroalkyl substances (PFAS) and ortho-phthalates are not intentionally introduced, and no materials used to replace the regulated chemicals are present in a quantity or manner that creates a hazard as great or greater than the hazard created by the regulated chemicals.

Standardization Administration of the People’s Republic of China (SAC) released four mandatory national standards on VOCs in coatings, adhesives, inks, and cleaning agents. Our products do not fall into these categories, are not manufactured in China, and have no residual VOCs.

These products do not contain mineral oil. This includes mineral oil aromatic hydrocarbons (MOAH) and mineral oil saturated hydrocarbons (MOSH).
